COMMITTEE DEMOCRATS PASS SB 1437!!!

BLATANT HOMOSEXUAL TEACHINGS ONE STEP CLOSER TO BEING IMPLEMENTED IN ALL CALIFORNIA SCHOOLS!!

**STATE SENATE COULD VOTE ON SB 1437
AS EARLY AS MONDAY, APRIL 10 th!!**

SB 1437 by Kuehl (D): Pro-Homosexual Curriculum

Earlier this week, on April 4 th, liberal Democrats on the Senate Judiciary Committee banded together and passed SB 1437! The only Republican on the committee, Senator Dick Ackerman, voted no. The other Republican seat is vacant.

Because of three Democrats votes for the bill our schools are one step closer to being forced to implement pro-homosexual textbooks and lessons and our children are one step closer to being forced to be taught about blatant homosexuality! Those Democrats were Senator Joe Dunn of Garden Grove, Martha Escutia of Whittier and Sheila Kuehl of Santa Monica, the author of SB 1437.

SB 1437 is now before the entire State Senate and could be voted on as early as Monday, April 10 th!

You must call, email or fax your local State Senator right away!! Ask them to vote NO on SB 1437!!

Remember, California's young students are the target of liberal legislators who wish to have every classroom blatantly teach and advocate homosexuality. It has been their goal to infiltrate the classroom for decades! Senator Kuehl recently said to the press, "We've been working since 1955 to try to improve the climate for in schools for gay[s]..."

Even the executive director for the group sponsoring SB 1437 admitted their real agenda...

“Public schools should be teaching about all of our [homosexual] history...What this bill does is it ensures that students get a full and complete education.”

Senator Kuehl’s bill will ban teacher instruction, all school activities, and all textbooks that she claims would “reflect adversely” upon a person due to their gender, sexual orientation, race, ethnicity, nationality, disability or religion.

This means that no statement could be made that could be considered negative against homosexuality and all textbooks would have to positively portray the homosexual, bisexual or transgender lifestyles.

SB 1437 is clear... No teacher , no school sponsored activity, no textbook, no instructional materials shall give instruction or contain **“any matter reflecting adversely upon persons because of their...gender...or sexual orientation...”**

SB 1437 cleverly accomplishes two major goals of radical homosexual activists: It gives pro-homosexual teachers free reign to teach whatever they want about the alleged positive aspects of homosexuality— **and it silences all opposition to it.** Teachers would be free to promote homosexuality but banned from discussing any negative consequences.

They want every student in the state to read from textbooks that say homosexuality is ok and should be tried. They want every student to see pictures of homosexual couples in their workbooks. For every family portrayed with a mom and dad their must be a “family” with two men or two women.

School-sponsored activities including everything from cheerleading, sports, plays, to proms would be affected. Under SB 1437 school districts would likely be prohibited from having a prom king and queen because that would show bias based on gender and sexual orientation. Don’t think this is far-fetched. In February at Hood College in Maryland, a lesbian was elected homecoming king beating out three men.
